**Please Read The Following Rules Carefully**

- 1] The law requires a Student to carry his/her red/white temporary permit or black/white temporary permit and picture ID while operating a motor vehicle.
- 2] If the Instructor is late for your appointment, please be patient. Call our office after 15 Min.
- 3] If you must cancel a driving lesson, a 24 hour notice must be given. Weekend appointments must be cancelled no later than 3:00 p.m. Friday. If we are not in the office, please leave a detailed message with our answering service. Failure to cancel or change an appointment within 24 hours, or Friday by 3:00 p.m. for weekend appointments, will result in a \$30.00 fee. This fee also applies if you do not have a VALID TEMPORARY PERMIT and PHOTO ID in your possession when the Instructor arrives; or for any reason you are not prepared to take your scheduled appointment.

\*A valid temporary permit means you have taken and passed the written/computer test at the exam station.

- 4] If weather conditions are unfavorable, you will be notified and your lesson will be rescheduled.
- 5] Once your driving lessons are scheduled, AMS will only contact you if we must change a lesson.
- 6] If you feel that you have not had proper and courteous instruction, please notify Management.
- 7] Any citation issued to a student during the practical training is the responsibility of the student. This includes camera surveillance.
- 8] AMS reserves the right to refuse any person service.

The School shall furnish a licensed Instructor and a motor vehicle for instruction. The Driving School does not guarantee the issuance of a driver's license to the student.

Commercial driving schools are licensed by the Department of Public Safety through the Governor's Highway Safety Office, 1970 West Broad St., Columbus, OH 43223

**Adult lessons: \$60.00 per lesson for the first four lessons: any additional lessons- \$50.00 per lesson. Each lesson is 1 ½ hours.**

Use of vehicle for State driving test in Lucas County:

If you have a ride to our office: \$25.00

If an instructor needs to pick you up and bring you to the exam station: \$60.00

Use of vehicle for State driving test in Wood County: \$70.00
